# Kingshill Parish Church Trustees' Report Year ended 31 December 2023

The trustees present their Annual Report and Financial Statements of the charity for the year ended 31 December 2023. The financial statements have been prepared in accordance with the accounting policies set out on page 16 of the accounts and comply with the General Assembly Regulations for Congregational Finance, the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published on 16 July 2014.

## **Objectives and Activities**

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

As a Parish Church in the Church of Scotland, we operate from two buildings, Trinity Church in Westhill and Skene Kirk in Kirkton of Skene. We share our building in Westhill with our friends, the local Roman Catholic Church. Trinity Church is also home to a number of non-Church community organisations.

As Moderator of the Kirk Session, the Minister is assisted by other office bearers and leaders of Church organisations in the completion of this report which covers our objectives, activities, achievements and performance.

#### A summary of the values that are important to us.

Our desire is to be

- strongly and deeply rooted in our faith, with the help of God's grace and the Holy Spirit
- · committed to caring for creation,
- reaching out and reflecting the love of God the Father into our community and the wider world; and
- · sharing the gospel of Jesus Christ with every generation.

We do this by seeking to listen to God and to encourage one another as we journey together.



#### **Achievements and Performance**

Following all the preparations that had been made in 2022, Kingswells and Skene came together in 2023 to form the newly united congregation of Kingshill Parish Church of Scotland (Aberdeenshire). It was wonderful to welcome Presbytery to a service of union and introduction at Trinity Church in July and to celebrate our coming together.

With the union and considerable work in the community, it has been another significant year in the life of our Church. We said goodbye to our Associate Minster, Rev Ibidun Daramola, and welcomed a new member of staff, Fiona Blair DCS. We are looking forward to expanding the team further in 2024.

We have welcomed a number of new members into our congregation, with significant change happening throughout the Church of Scotland and with the arrival of asylum seekers in our community.

We take this opportunity to thank all those involved in the life of the Church, from those working behind the scenes to those who serve as convenors, or who take upfront roles. It is a great team effort and much appreciated.

#### Worship and Pastoral Care

For the first six months of the year, we rotated between the three buildings across the two parishes. This enabled us to build relationships across the uniting congregations and meet the practical challenges of the ministry team being reduced. We continued to provide an online option.

Following the summer, we moved to Sunday services in both church buildings and a regular livestream from Trinity Church. Later on in the year, we established a monthly service in Kingswells in the Village Hall, following the closure of the church there. Our numbers have held steady between 100 and 120 people and we know that those who watch online very much appreciate being part of worship.

We have continued publishing our weekly service sheets, including bible readings and prayers, and have found it increasingly helpful to continue to provide a weekly email update to our members, which helps us share information about what is happening in the Church and community.

By the end of the year, we were running monthly services at Pitcairn Lodge, Blackhills Court and Kingsmead Care Home. We were delighted to welcome residents from Pitcairn Lodge to Sunday worship and are thankful to the staff who enabled this to happen.

Our Afternoon Tea Services at Trinity continued to provide an opportunity for older members of our congregation to gather in worship and fellowship.

In Lent, we were delighted to meet in person with our friends from the Roman Catholic and Westhill Community Church congregations. We enjoyed worship and lunch together. This culminated in a joint Good Friday service at Westhill Community Church, which was incredibly special.

During May we held two special events to celebrate the life of Skene Parish and to prepare ourselves for the union. The closing service at Kingswells Church was very well attended and a thanks was given to those who had supported the Church in recent years.

Westhill Prays, our monthly ecumenical prayer gathering, ran steadily throughout the year.

Our Pastoral Care team visited many homes during the year, together with the ministry team undertaking hospital visiting. Hope Café, a grief support group, met once a month at Trinity Church and we welcomed new attendees. Warm Wednesdays moved to a monthly gathering for soup and sandwiches. These opportunities to be together and support one another are much appreciated.

As with any year, 2023 saw the death of a number of our members and elders, including, Mrs Sandra Lyall (retired Elder) and Mr Gordon Argo (Elder Emeritus) and two retired ministers, Rev John MacLean and Rev Angus Haddow. We give thanks for the faithful service of these brothers and sisters in Christ. In December we participated in a memorial service organised jointly with Berriedale Funeral Home.

#### **Community Outreach**

A significant development this year was the opening up of the Hampton Hilton Hotel as an asylum seekers' hotel. We were invited into a conversation with Aberdeenshire Council, together with other community representatives. This followed on from our work with the Westhill Resilience Group during the pandemic.

We have helped to welcome over 200 service users. We have organised clothing donations, purchased essentials, and raised funds to support them. In conjunction with volunteers from the community we have been involved in establishing a Conversation Hub at Trinity Church, which enables them to socialise and practise their English. A number of our members are also involved in providing ESOL classes. It has been an amazing team effort, and the work will continue.

We have loved welcoming a small group of asylum seekers into our Church Family.

#### Staffing/Volunteers

We were sad to say goodbye to Rev Dr Ibidun Daramola at the beginning of the year. After going through the MDS recruitment process, Fiona Blair DCS was appointed as our Deacon. She joined the Ministry Team in September and, in the future, will be located at Kirk Cottage.

During the year, the Presbytery agreed to the allocation of an additional 0.5 post, with a specific remit around the community of Kingswells. This will be advertised in 2024.

Once more, a big thanks goes to all our staff members, convenors and volunteers. There is a huge amount of work that goes on to ensuring we are able to function as a Church, but also in our outreach work in the community and our schools' work.

#### Strategic Planning

Our "Cabinet" met on a monthly basis prior to the union, as agreed by the Kirk Session. It consisted of the treasurer, secretary, clerks and ministers. It considered the business of the Church and helps in the preparation for Congregational Board and Kirk Session meetings.

Following the union, we have undertaken work to restructure the Kirk Session into a number of committees and will form a Parish Leadership Team to replace the Cabinet. This will consist of the convenors of each of the committees, the clerks, treasurer, secretary and minister.

During the year the following matters were progressed:

- Plan to extend the building at Trinity Church to expand office space. This was progressed throughout the year and permission from the Presbytery of the North East and Northern Isles and the General Trustees was sought. Following the union, there are funds in our Consolidated Fabric Fund which should enable the work to start, once the tender process is complete.
- Kirk Cottage was taken off the market following an offer that fell through. It was agreed that the cottage should be rented to our deacon and preparations were made for this to go ahead in 2024.
- Our property planning included considering the sustainability of the Trinity Church building and what could be done around decarbonising the building. Grants were sought to move this forward, and works will be undertaken in 2024.
- Significant work will also be undertaken in 2024 with regards to the plant room at Trinity and the heating system.

#### **Children and Young People**

Messy Church ran on the last Sunday of each month. We look forward to continuing to build our relationships with the families that attend and hope to increase the numbers attending in the coming year as we continue with this outreach.

Skene Club has continued to run from the end of September to the beginning of March. The club has been well supported with an average of around 30 of Skene School's Primary 1 to Primary 7 aged children attending each Thursday night for an hour of noisy, sweet-fuelled fun.

The Boys' and Girls' Brigades ran successful programmes in 2023, with numbers increasing across both.

2023 saw the chaplaincy team being able to meet more regularly in the schools and to provide assemblies and pastoral care, including big end of term assemblies. We very much value our relationships with each of the schools across the parish.

Our 2023 Holiday Bible Club was based at the Westhill Community Church. It was well attended, and as always, there was a lot of fun across the week.

Thank you to Callum Ross, our Children and Families Worker, for his ongoing efforts throughout the year to support our children and young people.

#### **Looking Forward**

We continue to be in a season of transition as we continue to get to know one another in the united congregation, and as we plan for the work of the extension.

Once the team is supplemented, the question of what mission looks like across the parish will come back to the fore. Our newly established Mission and Outreach Committee will be involved with this

We trust that God will continue to lead us and equip us for the work He is calling us into. His grace and love make what we do possible. And we trust that all we do is for His glory.

## Safeguarding

Opportunities for young people to meet continued this year through Girls' Brigade, Boys' Brigade, Skene Youth Club, Jigsaw, GRID and Messy Church. Warm Wednesdays continued, providing a snack and social meeting opportunity, for people who are lonely or concerned about the significant rise in heating bills over the wintertime. The work of protecting these groups continues in terms of Safeguarding, ensuring safe recruitment and training of volunteers.

Kingshill Parish Church has three Safeguarding Co-ordinators. There are fifty-one volunteers on the Safeguarding Congregational Register who work with children and young people, seven volunteers on the Register for work with protected adults and nine volunteers with PVG clearance for both. Thirteen volunteers attended introductory level safeguarding training in 2022/ 2023. Forty-one Trustees (Elders) also undertook the appropriate level of training this year.

The Kirk Session is updated regularly with changes to the Safeguarding Congregational Register along with developments or changes made by the General Assembly and the Church of Scotland Safeguarding Service.

#### **Financial Review**

Our main source of income relies on members giving regularly to our Church. Income from offerings, including tax recovered on Gift Aid, amounted to £132,509 which was marginally ahead of the previous year. There was no legacy income in 2023, compared with £101,500 in 2022.

It is pleasing to report a significant increase in letting income on 2022 with £21,140 being generated from lets at Trinity Church. Income from the deposits with the Church of Scotland Investors' Trust was significantly greater due to both additional sums on deposit and much improved interest rates.

Grants of £15,500 to support the Children & Families work and our employment of the Children & Families Development Worker were received in the year. Of this, £12,500 was from the Joseph Rank Trust who supported the Church in both 2021 and 2022.

On the union with Kingswells Parish Church on 1 July, monies held by Kingswells were transferred to Kingshill. The total of £32,293 is included as Other Income and as a result reduced what would have been a significant deficit for the year.

Our total expenditure of £238,998 was some £26,000 greater than in 2022. The most significant increases in expenditure were in salaries, fabric repairs and maintenance, with several property repairs and improvements being completed, and heating and lighting where new contracts have resulted in much higher utility bills.

Overall, the accounts show a deficit of £16,473 for the year; without the funds received on the union with Kingswells the deficit would have amounted to £48,766. This compares with a surplus of £65,455 in 2022 although it should be noted that this was after the legacy income of £101,500 referred to above.

We continue to be extremely grateful to all our members who give regularly and most generously to support the work of the Church.

#### **Risk Management**

The trustees have identified that the principal risks and uncertainties facing the Church are:

#### 1. An ageing congregation

In order to minimise the impact of an ageing congregation and a drop in numbers through illness or death, the trustees established and are continuing to support the Messy Church Project Fund. This fund is used to employ our Children and Families Worker. The main aim of the project is to develop and deepen relationships with young families who have a connection with the Church and also those with no Church links. In addition to this project, we continue to investigate ways of developing our Sunday morning services to welcome and attract the younger generations.

We are also striving to provide services to assist the elderly to attend services of worship and Church events by, for example, providing transport.

#### 2. A reduction in regular giving

Regular monitoring of income and expenditure gives an opportunity to bring to the trustees' attention any significant changes to our financial situation and where appropriate take early action.

#### 3. Building repairs

Kingshill Parish Church has responsibility for the care and repair of four properties vested in the General Trustees of the Church of Scotland. Regular assessment of these properties is carried out and any work required is done timeously. There are also ongoing annual maintenance contracts in place for boiler servicing, fire alarms and fire extinguishers.

#### 4. Data Protection

The charity trustees are aware of the importance of protecting personal data. In order to minimise any risks which may result in the loss of data, all Office Bearers have been trained in Data Protection principles, and the Church has invested in encrypted hardware for storing electronic data. Personal and financial records are all stored in securely locked cupboards.

# **Reserves Policy**

The charity trustees have considered the reserves required and have taken into account their current and future liabilities. At a meeting of our trustees in June 2016, the trustees agreed to amend the ideal amounts held in our reserves and these have been approved again.

The Reserves Policy was amended to hold ideal reserves of £60,000 in our General Fund, which equates to four months' worth of expenditure. The reserves are held by the congregation to meet the day-to-day running costs of our two churches. Reserves are also held in the Designated Fabric Fund to meet future capital requirements and significant building repairs.

At the year end the Church held unrestricted funds of £153,655 of which £65,385 had been designated to the Fabric Fund. The remaining balance of £88,270 is held in our General Fund to meet our day-to-day expenditure.

The Church also held £137,342 of restricted funds which have been provided for the purposes specified in Note 15 of the Notes to the Financial Statements.

# Structure, Governance and Management

The congregation is a registered charity, number SC009462. The congregation operated under the Model Deed of Constitution for the first six months of the year and on 1 July 2023 moved to being administered in accordance with the terms of the Unitary Deed of Constitution and is subject to the Acts and Regulations of the General Assembly of the Church of Scotland.

#### **Trustees**

Members of the Kirk Session are the charity trustees. Up to 30 June 2023 members of the Skene Parish Church of Scotland Congregational Board were also trustees. The Kirk Session members are the Elders of the Church and are chosen from those members of the Church who are considered to have the appropriate gifts and skills. The Minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery. Elders from both Kingswells Church and Skene Parish Church were invited to join the Kirk Session of the united congregation from 1 July 2023.

#### **Congregational Board**

The Congregational Board ceased to exist on 30 June 2023, when the parishes of Skene and Kingswells joined together to become Kingshill Parish Church under a Unitary Deed of Constitution.

Congregational Board Members were appointed from within the congregation, and members of the congregation were invited to nominate individuals who were believed to have the skills and commitment to contribute to the management affairs of the Church, and to become members of the Board.

In 2023, the Congregational Board was chaired by the Minister and met in March and May. Up until the dissolution of the Board on 30 June 2023, the Congregational Board had 22 members, comprising 9 elected representatives of the congregation and 13 Elders.

#### Kirk Session

The Kirk Session is responsible for spiritual affairs within the Church. The Kirk Session comprises the Minister, Deacon, Children & Families Development Officer and 56 Elders (24 male and 32 female). During 2023, the Kirk Session met for ordinary business on five occasions as Skene Parish and on four occasions, following union, as Kingshill Parish Kirk Session. There were an additional three meetings involving all of the charity trustees.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The trustees are responsible for the maintenance and integrity of the charity and financial information on the congregation's website. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

# **Accounting Policies**

The principal accounting policies, which have been applied consistently in the current and preceding year in dealing with items which are considered material to the accounts, are set out below.

#### **Basis of preparation**

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS102) issued on 16 July 2014 and the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102), the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended)

#### Fund accounting

Funds are classified as either restricted funds or unrestricted funds, defined as follows.

Restricted funds are funds subject to specific requirements as to their use which may be declared by the donor or with their authority or created through legal processes, but still within the wider objects of the charity.

Endowment funds are funds which have been given on the condition that the original capital sum is not reduced, but the income there from is used for the purpose defined in accordance with the objects of the charity.

Unrestricted funds are expendable at the discretion of the trustees in furtherance of the objects of the charity. If parts of the unrestricted funds are earmarked at the discretion of the trustees for a particular purpose, they are designated as a separate fund. This designation has an administrative purpose only and does not legally restrict the trustees' discretion to apply the fund.

#### Incoming resources

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received, and the amount can be measured reliably.

#### Donated services and facilities

Donated professional services and donated facilities are recognised as income when the charity has control over the item, any conditions associated with the donated item have been met, the receipt of economic benefit from the use by the charity of the item is probable and that economic benefit can be measured reliably. In accordance with the Charities SORP (FRS102) the general volunteer time of congregation members is not recognised.

On receipt, donated professional services and donated facilities are recognised on the basis of the value of the gift to the charity which is the amount the charity would have been willing to pay to obtain services or facilities of equivalent economic benefit on the open market; a corresponding amount is then recognised as expenditure in the period of receipt.

#### Interest receivable

Interest on funds held on deposit is included when receivable and the amount can be measured reliably by the charity; this is normally upon notification of the interest paid or payable by the Investors' Trust.

#### **Fixed Assets**

The charity has the right to occupy and use for its charitable objects certain tangible fixed assets, including the church, halls and manse, vested in the Church of Scotland General Trustees. No consideration is payable for the use of these assets. Expenditure incurred on the repair and maintenance of these assets is charged as resources expended in the Statement of Financial Activities in the period in which the liability arises.

All tangible fixed assets costing in excess of £750 having a value to the charity greater than one year, other than those acquired for specific purposes, are capitalised. Depreciation is provided on a straight-line basis to write off the cost or initial value, less residual value, of tangible fixed assets over their estimated useful lives:

Fixtures, fittings and office equipment - 5 years.

#### **Taxation**

Kingshill Parish Church is recognised as a charity for the purposes of applicable taxation legislation and is therefore not subject to taxation on its charitable activities. The charity is not registered for VAT and resources expended therefore include irrecoverable input VAT.

All Church of Scotland congregations contribute to the National Stipend Fund which bears the costs of all ministers' stipends and employer's contributions for national insurance, pension and housing and loan fund. Ministers' stipends are paid in accordance with the national stipend scale, which is related to years of service. For the year under review the minimum stipend was £30,135 and the maximum stipend (in the fifth and subsequent years of service) £37,032.

#### 8. Trustee Remuneration and Related Party Transactions

During the year 8 trustees received reimbursement of expenses incurred totalling £1,920. These incidental expenses included stationery items, postages, cleaning materials and catering items.

Kingshill Parish Church met the costs of council tax and also pastoral telephone and broadband charges for Rev S Campbell. Total costs amounted to £3,436. Telephone and broadband charges of £197 incurred by Deacon F Blair were also met by the Church.

In addition, Mrs E Will received £8,076 for secretarial services at Trinity & Skene Churches, Mr B Milne received £3,217 for Church Officer duties at Skene Church, Mrs M Singer received £4,292 for cleaning duties at Trinity Church, Mrs J Cozens received £5,020 for Organist services and Mrs E Norris received £5,361 for Warden duties at Trinity Church.

During the year a total of £23,625 was donated to the congregation by trustees.

#### **Purposes of Endowment Funds**

Income from the Agnes Smith Bequest Fund is paid to the Parish Minister on 31 December each year to be used at her own discretion.

#### **Purposes of Restricted Funds**

Elsie Duguid Legacy: This legacy has been earmarked for fabric projects in our Church buildings.

Flower Fund: This is a fund to provide flowers to enhance the beauty of the Church.

Rabboni Fund: This fund provides for a gift to people in the Parish, of a plant on the first anniversary of the death of a loved one.

Action Group Fund: This is a fund to provide social events and companionship for older people in the Parish of Skene.

Eco Congregation Fund: This fund has been established as part of our work as an 'Eco Congregation' and caring for our environment.

Guild: Women and men from all walks of life who meet together with the common aim of committing their lives to Jesus Christ and expressing their faith in worship, prayer and action.

Afternoon Teas: A fund established from the sale of refreshments at Wednesday afternoon teas, now discontinued. The surplus will be used to support future projects.

Youth Club: Evening fellowship and fun for young people in the Parish of Skene.

Messy Church Project Fund: Fund to develop and deepen relationships with young Church families and also those with no Church links.

Pastoral Care Fund: A fund established for those in the parish who need extra support and care during periods of illness. Expenditure is at the discretion of the Parish Minister.

Kingswells Outreach Fund: This is a fund to help finance aids to worship and outreach projects with particular emphasis on the Kingswells community.

#### Purposes of Designated Funds

Fabric Fund: Is used to meet the costs of upgrading our buildings and significant building repairs to our four Church properties

Emergency Repairs Fund: Was used to fund repairs to both Church buildings. The balance on this fund was transferred to the Messy Church Fund at the end of the financial year.

#### 16. Lease commitments

A 5-year lease of a photocopier in the Church Office was renewed in 2022. As at 31 December 2023 the future commitment for payments in relation to this lease was £3,052.
